Ukraine announces today the preliminary results in connection with the solicitation of consents (the "**Consent Solicitation**") of holders of the Securities (the "**Holders**") to consider, and if thought fit, to adopt the extraordinary resolution (the "**Extraordinary Resolution**") at a meeting of the Holders to be held on 10 August 2022 (the "**Meeting**") to approve the Proposed Modifications (as defined in the Consent Solicitation Memorandum).

The Consent Solicitation was announced on 20 July 2022, on the terms and subject to the conditions set out in the consent solicitation memorandum dated 20 July 2022, as amended on 22 July 2022 and 3 August 2022 (the "**Consent Solicitation Memorandum**").
